1. INTRODUCTION

- 1.1. The Nottingham College health and safety policy has been produced in accordance with section 2(3) of the Health and Safety at Work etc. Act 1974. The Health and Safety at Work Act places duties in respect of health and safety on employers and employees and on each person who has, to any extent, the control of the college premises. The Management of Health and Safety at Work Regulations 1999 extend these duties in various respects.
- 1.2. This health and safety policy is the central document in the corporation's health and safety management system. The corporation's health and safety objectives are stated within the policy document arrangements, and the policy is led by and designed to meet these objectives. Documents and procedures are, where appropriate, implemented to enact the policy, and are in turn led by the corporation's objectives.
- 1.3. This health and safety policy is not a standalone document; health and safety affects all parts of the organisation and impacts significantly upon the wellbeing of employees, students, and members of the public. The health and safety policy is therefore closely aligned to the corporation's aims and objectives and its policies and procedures.
- 1.4. Nottingham College's board have ultimate responsibility to take all measures within their power to ensure the college environment is safe and risks regarding the health and safety of the staff, students and members of the public are maintained at an acceptable level.
- 1.5. The corporation's health and safety vision is explained in the aims and objectives section, with its commitment to health, safety and welfare is expressed in the policy statement. This is a broad outline of the corporation's commitment to the management of health, safety, and welfare.

1.6. Allocation of responsibilities

- 1.6.1. All employees are responsible for health and safety at work. They must take reasonable care of their own health and safety and that of others who may be affected by their acts or omissions and must co-operate with their employers on health and safety matters.
- 1.6.2. The CEO and Principal will ensure, through the Director of Estates and Facilities and the health and safety manager, that appropriate measures are implemented and carried out.
- 1.6.3. The Director of Estates and Facilities will co-ordinate health and safety policy and practice across the college however, some staff have additional responsibilities for health and safety due to their role or seniority in the organisation and will, in turn, be responsible for health and safety within their respective areas.
- 1.6.4. This policy document gives details of the specific responsibilities of all members of staff in the responsibilities section. A copy of this policy document will be made available to all staff. The reference material referred to in the document is held by the safety advisors and is available to all staff.
- 1.6.5. Persons responsible for health and safety matters cannot delegate their responsibility to others. It is acceptable to delegate specific tasks to other persons provided the responsible person is satisfied that those tasks are fully and properly carried out. In

practice, this means that managers will often distribute specific tasks to individuals or groups but should periodically check that their instructions have been followed.

- 1.6.6. Documents and procedures issued in support of this policy will require the performance of specific tasks by employees. These tasks can be delegated by the responsible person provided that they are satisfied that the task will be carried out safely.
- 1.6.7. Failure to carry out a task or responsibility specified in the health and safety policy or in any associated procedure or deliberate or negligent infringement of any part of the health and safety policy may lead to disciplinary action.
- 1.7. The way in which the corporation shall achieve its policy is explained in the arrangements section. This section is divided into individual topics so that it can be easily referred to and updated. The objective of each of these arrangements is stated within the appropriate section.
- 1.8. The objective of this policy is to ensure Nottingham College accepts its statutory and moral duty to ensure, as far as is reasonably practicable, the health and safety of all employees and furthermore to ensure that any person engaging in activities undertaken by the college or on behalf of the college does not endanger themselves or others participating in any authorised college activity.
- 1.9. This health and safety policy is the central document in the college's health and safety management system. The college's health and safety objectives are to ensure compliance with all relevant statutory legislation and the policy is led by and designed to meet these objectives. Documents and procedures are, where appropriate, implemented to enact the policy and gain commitment of staff, students, other visitors and contractors on their responsibilities identified within this policy when undertaking any college activities. This includes employers of students in work placements and apprentices who also may be affected by their employer's activities, which is in turn led by the college's objectives.
- 1.10. The policy document gives details of the specific responsibilities of all staff in the responsibilities section. A copy of this policy document will be made available to all staff, both full-time and part-time. The reference material referred to in the document is held by the safety advisors and is available to all staff.

1.11. The policy is intended to:

- Comply with requirements of relevant legislation and current good practice.
- Assist in identifying significant hazards from activities and manage those risks.
- Promote and communicate the requirements of this policy and its associated arrangement documents that relate to health and safety at the college and any other associated areas of responsibility, to all staff, students and others who may be affected by the college activities, to include external contractors, visitors and employers responsible for students on work placements, work experience and apprenticeships.
- Promote a positive attitude to health and safety at the college amongst staff and students by the involvement of stakeholders at all levels in the management of health and safety.
- Ensure that employees, students and others are adequately informed of the relevant identified risks.
- Ensure that employees, students and others receive appropriate instruction, training and supervision.

- Consult widely with staff and students and with employee representatives on health and safety matters.
- Make arrangements for co-ordination and commitment to this policy and arrangements with other employers where college employees or students share premises, facilities or activities with persons working in other organisations.
- Monitor the management of risks to health and safety where persons from other organisations, including contractors, are working in college-controlled activities.
- Review the effectiveness of health and safety risk management and where appropriate, to implement improvements.
- Provide occupational health and safety advisory services.
- Ensure compatibility between the college's aims and objectives and its health and safety policies and procedures.
- Continually strive to improve in the way health and safety is managed at the college by monitoring health and safety performance.
- Adopt a non-bureaucratic approach to enabling compliance.

2. RESPONSIBILITIES

2.1. Governing body

- 2.1.1. The board of governors has overall accountability for college strategy and strategic oversight of all matters relating to health and safety for the college and should seek assurance that effective arrangements are in place and are working.
- 2.1.2. The information below details practical guidance that will assist in ensuring members of the governing body satisfy themselves that the college meets its health and safety responsibilities. This follows a plan, do, check, review structure.

Plan

- Ensure health and safety matters are communicated in a timely fashion from and to the governing body.
- Review the college's health & safety policy on an annual basis.
- Review the college's health and safety objectives from the annual report.
- Ensure that health and safety is regularly included on the agenda of governing body meetings.
- Be aware of significant health and safety risks faced by the organisation.
- Consider the health and safety implications of strategic decisions, such as large projects.

Do – seek assurances that:

- Health and safety arrangements are adequately resourced.
- There is a forum, such as the health and safety committee as a subset of the governing body, chaired by a member of the ELT, to oversee health and safety.
- The college has access to competent health and safety advice.
- There is a process for employees or their representatives to be involved and engaged in decisions that affect their health and safety.

Check

- Receive and reasonably evaluate leading and lagging data relevant to health and safety.
- Ensure that management systems allow the governing body to receive assurances about all college activities (including significant partnerships, collaborations and





wholly owned companies).

Review – seek assurances that:

- Receive and reasonably evaluate leading and lagging data relevant to health and safety; and where appropriate, ask for data on processes (preventative and maintenance) and competency indicators.
- Ensure that management systems allow the governing body to receive assurances about all college activities (including significant partnerships, collaborations).
- 2.1.3. What the governing body can expect from the health and safety team:
 - Annual reports on health and safety.
 - Briefing papers on significant safety events.
 - Submission of college annual KPIs.
 - Provision of contextual information of statistical information.
 - Training.

2.2. Senior leadership team

- 2.2.1. This group consists of the CEO and Principal, Deputy CEO and Principal, Executive Directors, Vice Principals and Directors who have the responsibility for influencing and shaping the strategic direction of the college. It is reasonable to expect that the senior leadership team will demonstrate the same leadership qualities in health and safety as they do in their academic or professional field. Making sure that staff students, visitors, and contractors are safe is an essential part of managing risk and the senior leadership team has an influential part to play.
- 2.2.2. Accountability will rest with senior leadership team. They will normally delegate the operational aspects of health and safety management to other tiers of managers however, they must implement a process to gain assurances that their responsibilities are being fulfilled.
- 2.2.3. The senior leadership team's responsibilities are outlined in the plan, do, check, review format below:

Plan

- Sign up to the college's health and safety policy statement as a demonstration of ownership and communicate its values throughout the college.
- Allocate sufficient resources to the management of health and safety.
- Set health and safety objectives for teams.
- Ensure that health and safety appears regularly on the agenda of meetings.
- Determine what health and safety risks should be included on the business register.
- Ensure emergency procedures encompass all relevant risks.
- Consider the health and safety implications of strategic decisions, such as large projects.

Do

- Implement the college's health and safety policy.
- Have regular communication meetings with the college's health and safety professionals.
- Attend the health and safety committee meetings, as appointed.
- Lead on campaigns to raise health and safety awareness and behaviour change.
- Discuss health and safety issues and performance at performance / development reviews.





- Lead by example by taking an interest in health and safety activities.
- On tours or visits, follow local procedures and ask about health and safety issues and how they are managed.

Check

- Check processes are working.
- Confirm that direct reports are aware of inspections and investigations in their departments, and any actions upon recommendation.
- Receive and review performance data, such as KPIs.
- Review deployment of resources, such as are sufficient, competent, and effective.

Review

- Review health and safety performance. Celebrate achievement and take corrective action where targets are not being met.
- Share the results with staff and students, seeking their views on improvement.
- Respond to reports, audits, health and safety committee recommendations and inspections from external and internal stakeholders, such as insurance providers, trade union safety representative, regulators and health and safety staff.
- 2.2.4. What the senior leadership team can expect from the health and safety team:
 - Annual reports and/or reports on health and safety.
 - Briefing sessions or papers on significant safety events or changes to legal requirements.
 - Submission of college annual KPIs.
 - Facilitate and advise on the development of the health and safety risk register.
 - Develop a health and safety competency and training framework.
 - Internal health and safety audits.
 - Advice on interpretation of health and safety legislation and best practice.

2.3. Assistant Principals

- 2.3.1. This group has responsibility for developing the strategic plan of a particular faculty / centre. As senior managers of the college, they are expected to implement local safety management arrangements and manage risk to protect staff, student, visitors, and contractors working in their faculty / centre. Assistant Principals need a clear understanding and oversight of the operations and activities undertaken in their faculty. department, or campus so that they are well placed to define the most appropriate local safety structures which will ensure integration with overall strategic direction of their faculty / centre.
- 2.3.2. The responsibilities of the Assistant Principals are outlined in the plan, do, check, review format below:

Plan

- Align the faculty / centre and health and safety plan to the college's strategy.
- Include appropriate health and safety risks in your faculty/ centre business risk register.
- Define the membership (including trade union membership) and terms of reference for the local health and safety working group or attend college wide management group until a faculty led one is established.
- Ensure staff consultation involves all appropriate stakeholders, including trade union and student representatives.
- Ensure that induction arrangements include relevant information for all new starters.

- Plan arrangements to manage health and safety, such as set up committee meetings, monitoring processes, determine KPIs, and identifying training, competency and development needs.
- Assign sufficient resources (competent personnel, with enough time and facilities).
- Plan arrangements to ensure the health and safety of all persons who may be affected, including contractors, students and visitors.

Do

- Put in place process to ensure all activities are appropriately risk assessed and controls are fully implemented.
- Ensure responsibilities are delegated and understood for tasks such as the completion of risk assessments.
- Chair local health and safety working groups.
- Produce and communicate the annual health and safety plan.
- Have a regular communication meeting with a local competent advisor.
- Have oversight of accident and incident investigations.
- Agree health and safety competency and development needs of all your staff and set a training objective.
- Assess the health and safety impact of new projects at planning stages.
- When purchasing equipment, consider the health and safety requirements / implications, set up, use, maintenance and servicing.
- Embed health and safety arrangements during procurement of contracts.

Check

- Attend safety inspections of local areas at appropriate intervals.
- Check that agreed health and safety training objectives are being met using the performance development process.
- Analyse safety information data to identify emerging trends in the faculty / centre such as accidents, sickness absence, training data.
- Keep staff informed by monitoring progress and actively seek their views on improvements, such as the local safety working group.
- Check that all actions and recommendations from health and safety processes, such as audits and inspections, are implemented.

Review

- Regularly review risk management processes.
- Take action to implement recommendations from the risk management review.
- Consider information from external and internal sources, such as audits and inspections by health and safety staff.
- Review personal health and safety performance and that of direct reports, celebrating their achievements.
- Use information to review the planning process.

2.3.3. What Assistant Principals can expect from the health and safety team:

- This should be a joint approach with significant contributions from local safety appointments, especially for area and departmental specific hazards such as radiation, occupational health, machinery and equipment, display screen equipment, and fire safety and evacuation planning, with support from the health and safety team.
- Communications about significant events and changes to legal requirements of relevance to the faculty / centre.

- Attendance at health and safety committee or other meetings where health and safety is discussed.
- Facilitate and advise on the development of a health and safety risk register.
- Information about accidents and incident occurring in the faculty / centre.
- Guidance on how to investigate incidents and health and safety issues.
- Action plans and recommendations from investigations.
- Advice on management actions and proportionate responses for incidents.
- Advice on interpretation of health and safety legislation and best practice.
- Training courses or delivery of presentations and information.
- Assistance on completion of faculty returns of KPIs.
- Assistance to managers during external audits, inspections etc.

2.4. Heads of Faculty

- 2.4.1. This group includes both academic and professional support colleagues who have the responsibility for the day-to-day implementation of activities and the management of colleagues in-line with the strategic direction of the faculty or department, such as a faculty area manager.
- 2.4.2. As a line manager, Heads of Faculty are managers are expected to implement local health and safety management arrangements, and to monitor and check their effectiveness.
- 2.4.3. Heads of Faculties' responsibilities are outlined in the plan, do, check, review format below:

Plan

- Set reasonable objectives to cover your area of responsibility, including allocation of work on risk assessments based on your senior managers work plan.
- Develop or use existing communication processes, such as team meetings, to keep your team informed and receive information back from team members.
- Plan deployment of resources to achieve your health and safety objectives, such as training.

Do

- Implement your local health and safety procedures and arrangements.
- Carry out health and safety plan and objectives.
- Ensure existing and new processes have risk assessments undertaken, recorded, and the risk assessments are communicated to staff, contractors, and students so that they understand and can follow all safe systems and control measures.
- Provide induction training for all staff and students in accordance with your training and competency framework.
- Ensure all new equipment is checked for hazards, and users are trained on safe systems of work and risk control measures.
- Implement your health and safety training objectives identified in your health and safety plans or from your risk assessments.
- Provide staff with health surveillance if identified in you risk assessments.
- Lead a programme of inspections and be involved in audits when asked.
- Lead on investigations into accidents and other reports, such as near misses.
- Take appropriate action when health and safety is likely to be compromised; if necessary, suspending an activity pending reassessment of the risk.





- Keep yourself up to date with health and safety requirement for your area of responsibility.
- Have an annual programme for statutory testing of equipment, as required for local exhaust ventilation, pressure systems and lifting equipment.

Check

- Monitor that risk assessments have been carried out, recorded and control measures are effectively implemented, through observation, monitoring or during inspections.
- Check that all statutory examinations are carried out within the prescribed timescales and that requirements and recommendations are acted upon, for example, local exhaust ventilation, pressure systems, and lifting equipment.
- Monitor the completion / progress of action arising from audits and inspections.
- Check your own progress and achievements against your health and safety plan and objectives.
- Monitor your training plans and safety induction, use your appraisal process for this.
- Analyse safety information data to identify emerging trends in your area of responsibility, such as accident, sickness absence and training data.
- Report on findings of inspections and actions undertaken to the local health and safety committee.
- Use safety information data to present information and discussion trends.

Review

- Review actions arising from audits to ensure they have been competed or progress is being monitored.
- Embed learning points from accidents and incident.
- Contribute to your Faculty/Department annual safety review.
- Respond to external influences such as the Health and Safety Executive (HSE) or other regulatory body visits, audits, and changes in legal requirements.
- 2.4.4. What Heads of Faculty can expect from the health and safety team:
 - Communication about significant events, changes to legal requirements of relevance to the faculty or department.
 - Attendance at local health and safety committees or other meetings where health and safety is discussed.
 - Information about accidents and incidents occurring in the faculty or department.
 - Participation in discussions to resolve local health and safety issues.
 - Action plan and recommendations from investigations.
 - Advice on interpretation of health and safety legislation and best practice.
 - Training courses or delivery of presentations and information.
 - Assistance of completions of faculty returns of KPIs.
 - Assistance during audits, inspections, and similar work.

2.5. Lecturers and supervisory support colleagues

2.5.1. This group has responsibility for directly overseeing activities of colleagues, students, or mixed groups. They are unlikely to be responsible for developing strategic direction. Examples include a technical officer supervising a laboratory or a supervisor of a frontline service.

- 2.5.2. As a staff member with a supervisory responsibility in a faculty or department such as a lecturer, supervisor, or a support team member you are expected to monitor and check that the local arrangements and rules and being followed. A critical aspect of this role is to ensure that any concerns with the effectiveness of local health and safety arrangements are communicated to the appropriate person to ensure that continual improvement of your health and safety management system.
- 2.5.3. The responsibilities of lecturers and supervisory support colleagues are outlined in the plan, do, check, review format below:

Plan

- Promote local understanding of health and safety policy and procedure.
- Plan and attend skill, knowledge, or refresher training. Deliver this training to students where appropriate, based on faculty and department training objectives and competency framework.
- Effectively communicate procedures based on risk assessments.
- Plan resources and ensure all staff and students understand what is expected of them.

Do

- Ensure staff and visitors are aware of and follow all relevant safe systems.
- Ensure visitors and contractors are provided with relevant health and safety information.
- Develop clear and concise procedures and include key safety information in them.
- Implement aspects of the health and safety plan locally.
- Ensure that colleagues and students have received induction training as well as relevant training appropriate to their role.
- Raise issues of non-conformance through local management.
- Be proactive in local workplace inspections and local safety working groups.
- Provide feedback on health and safety issues.
- Be involved in accident, incident, and near miss investigations.
- Report near misses to line management.

Check

- Ensure risk assessments have been carried out, are up to date, recorded, and that control measures are effectively implemented and understood.
- Ensure actions arising from audits and inspections have been completed or monitor progress.
- Regularly ensure compliance to health and safety objectives.

Review

- Provide feedback on local health and safety performance to line management and celebrate achievements.
- Review accidents and incidents and ensure lessons learnt from investigations are embedded into revised procedures.
- Contribute to local annual health and safety review, where requested by line management.
- 2.5.4. What lecturers and supervisory support colleagues can expect from the health and safety team:
 - Communication about significant events and any changes to legal requirements as appropriate.

- Attendance at local health and safety committees or other relevant meetings.
- Information about accidents and incidents occurring within a local workplace area.
- Participation in discussions to resolve local health and safety issues.
- Action plan and recommendations from investigations.
- Advice on management actions and proportionate responses to incidents.
- Advice on interpretation of health and safety legislation and best practice.
- Training courses and where relevant, delivery of presentations and information.
- Assistance of completing health and safety KPI data.

2.6. People services team

- 2.6.1. The responsibilities of the people services team are as follows:
 - Ensure that no part of this policy is in direct conflict with any of the College's employment, equal opportunities, or disciplinary procedures through the executive director of people services.
 - Arrange for occupational health services or assistance as required to implement any part of this policy through the people services team.
 - Arrange for examination by a competent medical practitioner and any appropriate health surveillance whenever required by this policy through the people services team.

2.7. The college's health and safety committee

- 2.7.1. The aim of the college health and safety committee's responsibilities are outlined below:
 - Consider the overall general standards of safety and any relevant matters that are
 outstanding to ensure that all parties are aware of these matters and the action
 being taken to adequately address them. Day to day matters are reviewed monthly
 by the college's health and safety management group.
 - Consult on proposals for the improvements, alterations, or additions to health safety and welfare matters.
 - Promote co-operation between employers, employees and students in the development and where appropriate carry out measures to ensure the health and safety at work of employees and others who may be affected by the work activity.
 - Monitor health and safety performance and where it is felt necessary recommend new health and safety measures and standards or revise existing ones.

2.8. The college's health and safety management group and local health and safety circles

- 2.8.1. The aims of the college's health and safety management group and local health and safety circles are to:
 - Address day to day matters which have health and safety, security, premises, or accessibility implications.
 - Monitor health and safety performance across the college and where it is felt necessary recommend new health and safety measures and standards or revise existing ones.
 - Progress actions resulting from the health and safety committee and consider recommendations resulting from workplace inspections and determine the implementation of those recommendations.

• Receive and review relevant health and safety policy and procedures and oversee the conducting of risk assessments in accordance with an agreed programme.

2.9. Health and safety for students

- 2.9.1. The tutors are responsible for the day-to-day health, safety and welfare of students.
- 2.9.2. Nottingham College seeks to make places where students study and the activities carried out, to include students who are employees in work placements and apprenticeship work locations, as safe as is reasonably practicable. We rely on student, staff, and employer co-operation to make the college and its activities as safe as possible for everyone's benefit.
- 2.9.3. Under certain circumstances legal action may follow if either the college, the students, or both parties are found to be negligent with regard to health and safety.
- 2.9.4. Students are therefore required to take all reasonable care to ensure that their actions do not endanger themselves or others. Whilst it is the responsibility of the college to provide and maintain equipment that is safe, students should not use any equipment they consider to be unsafe and should report it immediately to the person supervising the student or students.
- 2.9.5. Students must ensure that they are familiar with the relevant health and safety information and safe operation procedures in their curriculum area.
- 2.9.6. Students must not undertake any procedure unless authorised to do so.
- 2.9.7. 14-16 students will be subject to certain prohibitions these will be defined in the individual curriculum areas arrangements for young persons.
- 2.9.8. Students must familiarise themselves with relevant codes of safe practice which are provided in areas of higher risk for certain equipment, machines, and operations which they are authorised to use.
- 2.9.9. In the event of an accident involving personal injury or injury to others, the circumstances must be reported to the person supervising the student or students and first aid treatment must be sought.
- 2.9.10. The Management of Health and Safety at Work Regulations 1999 implemented the health and safety requirements of the Pregnant Workers Directive (92/85/EEC). The college wish to apply the same safety standards to students as to employees. This involves carrying out a risk assessment on college activities for any student who is pregnant, has given birth in the last six months, or who is breastfeeding. The aim is to reduce the risk of exposure to agents, processes, or conditions that present additional risks in students who are recently or currently pregnant or breastfeeding.
- 2.9.11. Nottingham College is committed to excellence in health and safety performance and to meeting its duties of care to the health, safety and wellbeing of its employees and students, as well as others, including visitors, who may be affected by the college activities. It recognises that this requires commitment to, and application of, good practice in health and safety by its managers and staff.

4. POLICY STATEMENT

Nottingham College Health and Safety Policy Statement

The corporation and senior management of Nottingham College accept that they have a statutory and moral duty to ensure the health, safety and wellbeing of all employees and students and that any persons engaging in activities undertaken by the college or on behalf of the college does not endanger themselves or others participating in any authorised college activity.

It is, therefore, college policy to:

- Implement our health & safety policy through the college health and safety management system in order to maintain a safe environment, so far as is reasonably practicable, thus ensuring the wellbeing of all staff, students and visitors, and to comply fully with the Health and Safety at Work Act 1974, all other statutory provision and approved codes of practice.
- 2. Provide and maintain premises, plant, equipment, systems of work, storage, transport and welfare facilities that are safe, where levels of risk are assessed and reduced to an acceptable level in order to help prevent accidents and cases of work-related ill health.
- 3. Seek to implement industry best practice by embedding a positive attitude towards health, safety, and welfare with an acceptance of individual and collaborative ownership and responsibility among managers, employees, students, visitors and contractors throughout the college.
- 4. Provide all employees, students and any others who may be affected by the operations or activities of the college with effectively communicated information, instruction, training and appropriate supervision so as to be able to work safely, ensuring that young persons in particular are protected by taking into account their individual capabilities, inexperience, and immaturity when identifying areas of risk.
- 5. Develop the college's health and safety policy in consultation with trade union appointed representatives and interested stakeholders so that employees and service users are given the opportunity to be effectively involved in the promotion of health, safety and welfare issues, and to value their contribution towards the achievement and maintenance of effective safety standards.
- 6. Provide appropriate resources to implement the college health and safety management system, ensuring that competent technical and professional advice on any item concerning matters of health, safety, and welfare that is outside the knowledge and experience of college employees, is available to the college.
- 7. Regularly evaluate and monitor health and safety performance against set metrics, and annually review the content, operation, and achievement of this policy by the presentation of a report to the board of governors of Nottingham College.
- 8. Undertake equality impact assessments as and when the health & safety policy is reviewed; it is intended that this policy and associated procedures will avoid discrimination and actively promote equality.

This policy statement and arrangements reflects the corporation, CEO and Principal and senior management teams' commitment to establishing and sustaining a positive health and safety culture and will be kept under annual review and amended as necessary.

4.1. Health and safety policy and statement review

- 4.1.1. Nottingham College recognises its statutory duty to provide effective reviewing of its health and safety provision. This is achieved by informal and formal arrangements. College managers, who upon identifying or becoming aware of ineffective health and safety practices or situations, will remedy accordingly and expedite a review.
- 4.1.2. The college health and safety committee and the board carry out a formal review annually.
- 4.1.3. The health and safety management group receives and considers procedures, codes of practice, and general health and safety systems in accordance with scheduled review dates or evidence of ineffectiveness.
- 4.1.4. The board receives and considers an annual report. The content of the report addresses the following items:
 - Summary of significant matters raised at health and safety committee meetings together with action taken to address those matters.
 - Statement regarding policy implementation and any suggested changes to health and safety policy.
 - Statement regarding current health and safety resources together with identified health and safety expenditure for the coming year.
 - Summary report covering accidents, incidents, and matters reported to the relevant authorities.
 - Statement regarding safety inspections, external audit reports, and other monitoring activities.
 - Summary of contact with enforcement agencies, for example, the Health and Safety Executive, Environmental Safety Officer, or the local fire and rescue service, including any enforcement notices received.
 - Major corporate health, safety, or welfare initiatives for the coming year or description of the health and safety plan.
 - Summary of outstanding health, safety or welfare matters from previous report.

6. MEASURES (SUMMARY OF ARRANGEMENTS)

6.1. The effectiveness of the policy will be monitored and measured in a variety of ways. These will include the following summary arrangements.

6.2. Risk assessments

6.2.1. Principles

6.2.1.1. Nottingham College recognises its statutory duty to carry out health and safety risk assessments.

- 6.2.1.2. Risk assessment is an essential component of good health and safety management. It is the tool used to ensure that the measures taken to prevent or reduce risk are appropriate, relevant, and realistic.
- 6.2.1.3. For risk assessments to be suitable and effective, the risk assessment process itself must not be inappropriately applied, unreasonably time-consuming or over-complex.

6.2.2. Objectives

- 6.2.2.1. To implement a risk assessment system that is effective, efficient, and suitable to meet Nottingham College's business needs.
- 6.2.2.2. To comply with the college's statutory duty to prepare suitable and sufficient risk assessments.
- 6.2.2.3. To contribute to the improved health, safety and welfare of the college's employees, students, and the general public through the identification and prevention or control of significant risk.

6.2.3. Policy

- 6.2.3.1. The law requires that all workplaces and work activities be examined with risk assessments undertaken including written assessments where hazardous activities are identified. Within the college, this means all areas and activities, including those involving students whilst studying.
- 6.2.3.2. The college is committed to fostering a positive health and safety culture, the foundation of which will be a proactive risk assessment regime which details the range of hazards associated with working operations and the remedial actions necessary to control any hazards to an acceptable level.
- 6.2.3.3. Managers are responsible for ensuring that suitable and sufficient risk assessments based upon the tasks that employees or students are likely to perform shall be carried out within each of the college's business areas.
- 6.2.3.4. Preventative and risk control measures identified by risk assessment shall be implemented within each area by the responsible manager.
- 6.2.3.5. Employees affected by each risk assessment shall be kept informed about significant risks, the measures implemented to prevent and control each risk, and the results of any review of the risk assessment carried out.
- 6.2.3.6. Each area shall monitor its own performance in order to ensure that the preventative and risk control measures that have been identified are properly implemented, observed, and effective. Risk assessments shall be reviewed at least once in every year, or whenever there is caused to believe that they are no longer valid.
- 6.2.3.7. The college shall maintain a register of all health and safety risk assessments which shall be regularly reviewed via the performance monitoring process. Staff will be able to access completed and in date risk assessments via the intranet.
- 6.2.3.8. Where the college's activities significantly impact on the health, safety, or welfare of other people not employed by the college, a risk assessment shall be





carried out by the area carrying out that activity to identify the significant risks and any appropriate preventative and risk control measures.

- 6.2.3.9. The college shall instruct all employees regarding the basic processes of health and safety risk assessment and shall encourage the participation of employees in the identification and reporting of risk.
- 6.2.4. Relevant legislation includes but is not limited to:
 - Health and Safety at Work etc. Act 1974
 - Management of Health and Safety at Work Regulations 1999

6.3. Staff consultation

6.3.1. Principles

- Nottingham College recognises its statutory duty to consult with employees 6.3.1.1. under the applicable legislation about specified health and safety matters.
- Nottingham College recognises that consultation is an essential step in the 6.3.1.2. normal management process.

6.3.2. Objectives

- 6.3.2.1. To comply with the college's statutory duty to consult with employees about the specified health and safety matters.
- 6.3.2.2. To contribute to the improved health, safety and welfare of the college's employees and students through consultation with those parties who are affected by the college's activities.

6.3.3. Policy

- Nottingham College will ensure as far as is reasonably practicable that it 6.3.3.1. maintains a safe and healthy working environment and that employees are involved in the process and their input is considered.
- 6.3.3.2. The experience and knowledge of applicable staff will be considered when health and safety policies and procedures are being developed and considered.
- Nottingham College will actively encourage staff to play an active role and have a stronger commitment towards health and safety to establish a joint problemsolving culture with a proactive approach.
- 6.3.3.4. Nottingham College will actively encourage a greater co-operation between all levels of staff towards developing and maintaining a strong and effective health and safety management system.
- 6.3.3.5. Nottingham College will ensure that appropriate staff are consulted where changes are planned, recent technologies introduced, or where potential risks are increased or introduced.
- 6.3.4. Relevant legislation includes but is not limited to:
 - Health and Safety (Consultation with Employees) Regulations 1996

6.4. Health and safety workplace inspections

6.4.1. Principles

- 6.4.1.1. Regular formal inspection of the college's workplaces and other areas under the college's control is an essential tool for the identification of hazards relating to the work environment.
- 6.4.1.2. The frequency at which inspections are carried out should be such that they are regular enough to identify emergent hazards, yet not so frequent that they become unreasonably time-consuming.

6.4.2. Objectives

- 6.4.2.1. To contribute to the improved health, safety and welfare of the college's employees, students, and visitors by regular formal inspection of workplaces to identify hazards and prevent or reduce any risk of harm.
- 6.4.2.2. To contribute to the improved health, safety and welfare of the college's students and visitors by regular formal inspection of public areas under the college's control.

6.4.3. Policy

- 6.4.3.1. Nottingham College shall ensure that health and safety inspections are carried out at frequencies appropriate to the level of risk.
- 6.4.3.2. The college shall appoint persons to carry out inspections of workplaces and other relevant areas at agreed frequencies in defined areas.
- 6.4.3.3. Persons appointed to carry out workplace inspections shall ensure that an elected trade union safety representative or other appropriate employee is afforded the opportunity to observe and contribute to the inspection. This shall not preclude the legal right of elected trade union safety representatives to inspect their workplace at least every three months (or more frequently by agreement).
- 6.4.3.4. Procedures shall be implemented to allow employees to report any unsafe condition observed in workplaces or other relevant areas.
- 6.4.4. Relevant legislation includes but is not limited to:
 - Safety Representatives and Safety Committee Regulations 1977
 - Workplace (Health, Safety and Welfare) Regulations 1992
 - Health and Safety (Miscellaneous Amendments) Regulations 2002

6.5. Health and safety accident / incident and near miss reporting

6.5.1. Principles

6.5.1.1. Health and safety incidents include injuries, dangerous occurrences, occupational ill health, and violent incidents which cause injury or illness to persons, damage to property or a combination of both.





- 6.5.1.2. A near miss is defined as an unplanned incident that does not cause injury or damage but had the potential to do so.
- 6.5.1.3. Appropriate procedures are necessary to ensure that incidents are properly reported and investigated so that the college can determine and address the root causes of the incident and prevent its re-occurrence.
- 6.5.1.4. Incidents will not be properly reported unless employees are made fully aware of the procedure and reasons for doing so and are reassured that they will not be unduly blamed for reporting incidents.

6.5.2. Objectives

- 6.5.2.1. To comply with the College's statutory duty to report certain classes of incident to the statutory authority.
- 6.5.2.2. To encourage the prompt and accurate reporting of health and safety incidents.
- 6.5.2.3. To reduce incident rates.

6.5.3. Policy

- 6.5.3.1. Nottingham College will endeavour to reduce the occurrence of accidents and diseases along with the related costs, lost time, and human suffering, embedding a culture in which employees understand that such events can be reported without fear of blame or harassment.
- 6.5.3.2. The college has established a reporting system for incidents and near misses. All incidents, including minor accidents requiring self-administered first aid, accidents requiring first aid treatment from a qualified first aider and/or medical treatment and near misses are required to be reported via the relevant reporting process.
- 6.5.3.3. Staff are responsible for ensuring that where they are notified of an injury to a student, visitor, or contractor in their care, an incident form is completed. The form is available in an electronic format on the front page of the college intranet or pre-printed copies are available on receptions.
- 6.5.3.4. The incident and near miss report forms are sent to college health and safety staff for review. Significant incidents shall be investigated for the purpose of ensuring that suitable measures are taken to reduce the likelihood of the event re-occurring and all RIDDOR reportable accidents are investigated as per statutory requirements. Incident forms must be distributed to:
 - Health and safety staff for monitoring and review
 - Relevant faculty area manager
 - Injured person
- 6.5.3.5. Elected trade union safety representatives shall be informed of accidents and ill health occurrences amongst the members they represent to enable them to fulfil their functions to investigate and inspect such events as provided for by law.
- 6.5.3.6. Where students are employed as part of a work placement or apprenticeship scheme, the employer has the responsibly to report any accidents under the RIDDOR





regulations. In addition the employer must report all accidents or incidents involving work placement and apprenticeship students to the college.

- 6.5.4. Relevant legislation includes but is not limited to:
 - Reporting of Injuries, Diseases and Dangerous Occurrences Regulations 2013
 - Safety Representatives and Safety Committee Regulations 1977
 - Occupiers' Liability Act 1957 and 1984
 - Health and Safety at Work etc. Act 1974
 - Management of Health and Safety at Work Regulations 1999

6.6. First Aid

6.6.1. Principles

- 6.6.1.1. The purpose of first aid is to sustain life, prevent deterioration in the existing condition, and to promote recovery until the appropriate medical assistance is available. As such, it is essential that there are sufficient trained personnel and facilities so that first aid assistance can be given to any employee or visitor who may be injured or become ill on college premises.
- 6.6.1.2. Arrangements are also required to ensure that appropriate equipment, communications, or assistance are available to peripatetic employees.

6.6.2. Objectives

- 6.6.2.1. To comply with the college's statutory duties relating to the provision of first aid facilities.
- 6.6.2.2. To ensure that first aid provisions are appropriate regarding levels of risk.

6.6.3. Policy

- 6.6.3.1. Within Nottingham College it is a relatively low risk environment although some areas have an increased risk within workshops and laboratories and procedures to reflect this. Incidents can be categorised into minor injuries, injuries requiring first aid assistance and emergencies.
- 6.6.3.2. The college shall, using risk assessment, ensure that there are sufficient trained persons to provide competent first aid assistance, or appointed persons to take charge of a medical situation for all its centres and leased premises in regular use as a college venue.
- 6.6.3.3. All staff should make themselves aware of who within their centre or area of operation is a trained first aider and how to contact them. Where required, a first aid duty rota may also be in operation to ensure appropriately trained first aiders are on call during weekday college opening hours.
- 6.6.3.4. Within the college there are three grades of first aid personnel:

6.6.3.4.1. Full first aider

6.6.3.4.1.1. Staff that have successfully completed a full first aid at work qualification as approved by the HSE are appointed as competent persons to provide first aid treatment and deal with a medical emergency. These appointed first aiders shall be paid a





premium at the rates published from time to time. This rate shall be periodically reviewed.

6.6.3.4.2. Emergency first aider

6.6.3.4.2.1. Staff that have completed an emergency first aid at work course and are able to deal with a medical emergency and summon assistance. These staff are not paid a premium as the qualification they hold is not a full first aid qualification.

6.6.3.4.3. Appointed person

- 6.6.3.4.3.1. Staff who have no formal first aid qualification and (where having regard to, the nature of the undertaking, the number of employees and students and the location it is identified in the risk assessment that it is adequate and appropriate to have no first aider) are appointed to take charge of situations relating to an injured person who will need help from a medical practitioner or nurse and to contact the emergency services accordingly. These staff are not paid a premium as they have no actual first aid qualification.
- 6.6.3.5. First aid kits are either, carried by duty first aiders or are permanently located in areas identified as medium risk areas such as workshops, laboratories, or salons. A first aid kit is also kept on reception for the use in evenings and weekends and in all reception areas.
- 6.6.3.6. First aid personnel are responsible for replenishing the contents of either the kits they carry about their person or the first aid kits they make use of within their departments. Stock for replenishment of kits is managed and distributed by the health and safety team.
- 6.6.3.7. Nottingham College shall ensure that adequate and appropriate equipment and facilities are available so that competent persons are able to provide first aid assistance.
- 6.6.4. Relevant legislation includes but is not limited to:
 - Management of Health and Safety at Work Regulations 1999
 - Health and Safety (First Aid) Regulations 1981
 - Health and Safety (Miscellaneous Amendments) Regulations 2002

6.7. Fire Prevention

6.7.1. Principles

- 6.7.1.1. The Regulatory Reform (Fire Safety) Order 2005 requires fire precautions to be put in place where necessary and it places an onus on the responsible person who may be the employer, owner, or occupier of premises to carry out fire risk assessments and to comply with fire safety duties.
- 6.7.1.2. Nottingham College recognises its statutory duty to carry out fire risk assessments and the requirement to comply with fire safety duties as identified within the Order.

6.7.2. Objectives





- 6.7.2.1. To implement fire precautions where necessary that are effective, efficient, and suitable to meet Nottingham College's statutory duty
- 6.7.2.2. To comply with the college's statutory duty to prepare suitable and sufficient fire risk assessments.
- 6.7.2.3. To contribute to the improved safety of the college's employees, students, and visitors through the identification and compliance with fire safety duties as identified within the Order.

6.7.3. Policy

- 6.7.3.1. Nottingham College will take all reasonably practicable steps to prevent or minimise the probability of all causes of fire. It is accepted that despite these measures it cannot be assumed that fire will not break out.
- 6.7.3.2. Fire risk assessments and regular audits and tests are carried out to inspect means of escape and maintenance of firefighting equipment and fire warning systems. Fire evacuation drills are undertaken in accordance with the regulations.
- 6.7.3.3. The College will exercise suitable control over contactors operations on site and the fire risks associated with their operations. All contractors working on any of the college sites are bound under contract to comply with the college's control of contractors procedure.
- 6.7.3.4. Faculties or departments within the college who are at a higher risk of fire and explosions occurring through their activities will conduct risk assessments ensuring they identify fire as a hazard and will implement control measures as necessary to reduce the risks to an acceptable level.
- 6.7.4. Relevant legislation includes but is not limited to:
 - The Regulatory Reform (Fire Safety) Order 2005
 - Management of Health and Safety at Work Regulations 1999
 - Furnishings (Fire) (Safety) Regulations 1988

6.8. Emergency evacuation

6.8.1. Principles

- 6.8.1.1. The Regulatory Reform (Fire Safety) Order 2005 requires the developing of an emergency action plan to include how the evacuation of premises will be carried out and states that an evacuation must be practiced at least annually.
- 6.8.1.2. Nottingham College recognises its statutory duty to develop emergency action plans and to carry out fire drills in the form of practice evacuations.

6.8.2. Objectives

- 6.8.2.1. To develop emergency action plans that are effective, efficient, and suitable to meet Nottingham College's statutory duty
- 6.8.2.2. To contribute to the improved safety of the college's employees, students, and visitors through the effective evacuation of buildings and premises.





6.8.3. Policy

- 6.8.3.1. Emergency procedures are required to ensure that all employees and visitors are quickly removed to a place of safety should a situation of serious and imminent danger occur, and that the situation is quickly dealt with by competent persons (usually outside agencies).
- 6.8.3.2. Nottingham College has emergency evacuation procedures that outline the evacuation process to ensure all staff, students, visitors and contractors, both able and disabled, can leave the buildings safely in an emergency.
- 6.8.3.3. It is important that all staff and students are aware of and fully understand these procedures and are responsible for making themselves aware of the buildings they work and study in and for ensuring that they are aware of the emergency exits.
- 6.8.3.4. Emergency evacuation practices are held to cover different days of the week and evenings. This is so that staff and students become familiar with the procedure and that observations can be made of the evacuation in order for improvements to be made if necessary.
- 6.8.3.5. Key staff will be trained as fire wardens to assist during fire evacuations and this training will also include principles of fire prevention.
- 6.8.3.6. Relevant legislation includes but is not limited to:
 - The Regulatory Reform (Fire Safety) Order 2005
 - Management of Health and Safety at Work Regulations 1999

6.9. Control of contractors

Principles

a. Although contractors are directly responsible for the health and safety of their own employees. Nottingham College needs to be assured that reasonable measures are in place during contract work to protect its employees, students and other affected persons from harm or loss.

Objectives

- a. To develop emergency action plans that are effective, efficient and suitable to meet Nottingham College's statutory duty.
- b. To contribute to the improved safety of the college's employees, students and visitors through the effective evacuation of buildings and premises.

Policy

From time-to-time Nottingham College will use contractors for facilities repair, maintenance and development work, although contractors are directly responsible for the health and safety of their own employees, the college needs to be assured that reasonable measures are in place during contract work to protect its employees, students and other affected persons from harm or loss.

- 6.7.2 The college shall introduce suitable procedures to ensure that health and safety is managed throughout each project life cycle, from conception to completion and that contract works are let only to persons or organisations that are competent to carry out the works in accordance with the relevant statutory provisions.
- 6.7.3 The college shall provide its contractors with any relevant health and safety information that is reasonably accessible to the college, and that would not normally be available to a competent contractor.
- 6.7.4 The college shall monitor the health and safety performance of its contractors and shall take the results of any such monitoring into account when letting or reallocating contract work.

Legal requirements

- Building Regulations 2000
- Construction (Design and Management) Regulations 2015
- Control of Asbestos Regulations 2012
- Health & Safety Management Regulation 1999

6.8 Asbestos management

Principles

- a. Nottingham College recognises its statutory duty to prevent or reduce the risk of harm to its employees caused by exposure to asbestos fibres in the air.
- b. The College also recognises its statutory duty to manage asbestos within buildings under its control so as to prevent or reduce the risk of asbestos fibres being released into the air.

Objectives

- a. To comply with the College's statutory duties relating to the management of asbestos and work with asbestos.
- b. To prevent or reduce any harm, suffering and lost time caused by exposure to airborne asbestos fibres.
- c. To provide information to relevant persons regarding the location of asbestos containing materials.

Policy

- 6.8.1 The College shall not knowingly expose its employees or any other persons to harmful levels of airborne asbestos fibres, and employees are not permitted to knowingly work on any asbestos-containing material in such a way as is likely to result in the uncontrolled release of asbestos fibres into the air.
- 6.8.2 The College shall keep and maintain information relating to the location of known asbestos containing materials in non-domestic areas and shall make such information available to persons who are likely to have cause to disturb such materials.

- 6.8.3 The College shall periodically examine the condition of materials within its buildings so as to ensure that such materials are not allowed to degrade to a condition whereby asbestos fibres are likely to be released into the air.
- 6.8.4 Any asbestos containing material that has to be removed to prevent or reduce the risk of harm shall be removed and disposed of by a licensed contractor.

Legal Requirements

- Health and Safety at Work etc. Act 1974
- Control of Asbestos at Work Regulations 2012
- Special Waste Regulations 1996

6.9 Legionella management

Principles

a. Nottingham College understands its responsibility to prevent or reduce the risk of the proliferation of legionella bacteria in stored water systems in premises managed by the College to below a level that harm may be caused to persons using the stored water supplies. The College shall implement reasonable measures to prevent or control the risk of legionella proliferation in premises.

Objectives

- a. To comply with the College's responsibilities relating to the management legionella.
- b. To prevent or reduce any harm caused by exposure to airborne legionella bacteria.

Policy

- 6.9.1 Nottingham College shall implement reasonable measures to prevent or control the risk of legionella proliferation in premises owned or managed by the College.
- 6.9.2 College employees who specify new or replacement hot water systems shall, where reasonably practicable specify new or replacement systems that reduce the amount of stored water supplies and ensure the removal of any dead legs from the system (or parts of) which is being renovated or replaced.

Legal Requirements

- Health and Safety at Work etc. Act 1974
- Control of Substances Hazardous to Health Regulations 2002

6.10 Health and Safety Provision for Pregnant Employees

Principles

a. Pregnant workers may be at greater risk of harm than other employees when carrying out certain tasks such as moving heavy loads, and their work must therefore be re-assessed to ensure that reasonable adjustments are made to their work routines where necessary to reduce the risk of harm.

Objectives

Nottingham College Health & Safety Policy





- a. To comply with the College's statutory duties relating to the employment of pregnant workers.
- b. To take reasonable additional steps to protect pregnant workers from any unacceptable risk of harm.

Policy

- 6.10.1 Pregnant workers may be at greater risk of harm than other employees when carrying out certain tasks such as moving heavy loads, and their work must therefore be re-assessed to ensure that reasonable adjustments are made to their work routines where necessary to reduce the risk of harm.
- 6.10.2 The college recognises that from time to time some of its female students may also be new mothers or pregnant, and where this is identified, the college has a duty-of-care to reduce the risk of harm to mother and child from its activities, wherever possible.
- 6.10.3 Nottingham College recognises that some of its operations may, unless properly controlled, pose specific risks to the health and safety of pregnant women and new mothers and will take all reasonably practicable measures to eliminate or reduce these risks to an acceptable level.
- 6.10.4 The College shall ensure an assessment is made of the risks to pregnant employees or students, paying particular attention to:
 - any nightshifts or extended working hours.
 - possible exposure to chemicals, radiation, lead or biological agents.
 - heavy manual work including manual handling.
 - any long distances or flights of stairs to be traversed at work.
 - the frequency and duration of rest periods.
 - the availability of rest facilities.
 - other hazards likely to affect the health and safety of the mother or child.
- 6.10.5 Reasonable adjustments shall be made where necessary to the pregnant worker's duties or pregnant student's activities in order to prevent or control any additional risk. If risks are such that they can no longer be reasonably and sufficiently prevented or controlled, the pregnant worker shall be offered an alternative task without detriment to her conditions of service or suspended until such a time as she is able to continue with her normal work in accordance with the College's employment policies and procedures.

6.11 Children, Young Persons and Vulnerable Adults

Principles

a. Education providers of both pre-and post-16 learning, and skills have responsibilities to ensure the safety of children, young people and those adults deemed 'vulnerable'.





Objectives

- a. To comply with the College's statutory duties relating to the health and safety of children, young persons and vulnerable adults in relation to the provision of
- b. To take reasonable additional steps to protect children, young persons and vulnerable adults from any unacceptable risk of harm.

Policy

- 6.11.1 Nottingham College recognises (for the purpose of this policy) that current health and safety regulations relating to the workplace define a child as someone who is not over the minimum school leaving age, and a young person as someone who is under 18.
- 6.11.2 A vulnerable adult is defined as a person 'who is or may be in need of community care services by reason of mental or other disability, age or illness; and who is or may be unable to take care of him or herself, or unable to protect him or herself against significant harm or exploitation'. NIACE (National Institute of Adult Continuing Education) (2007) Safer Practice, Safer Learning.
- 6.11.3 Safeguarding arrangements look at keeping children, young persons and vulnerable adults safe from a much wider range of potential harm and looks at preventative action not just reaction, where it is identified within these arrangements that there are significant workplace health and safety hazards risk assessments are carried out and control measures implemented with these persons in mind.

- 6.11.4 Children on campus

Procedure

- 6.11.4.1 Children (under 18 non-students) who are attending site with a enrolling student (their parent or quardian) must be under the responsibility and supervision of their parent / guardian at all times.
- 6.11.4.2 Student can only bring under 18 children onto campus, as a last resort, during their initial 1-2-1 meetings with tutors, and must be under the responsibility and supervision of their parent / guardian at all times such as:
 - Initial assessments
 - **Enrolments**
- 6.11.4.3 Children can accompany a parent or guardian only to pre-arranged activities on campus, and must remain under the supervision/ responsibility of the parent/ guardian and all times, such as:
 - Open evenings and events that are open to the public
 - Pre-arranged activities e.g. Family Learning projects
 - Visits to campus by staff e.g. Staff with newborn

- 6.11.4.4 Staff who are working on campus cannot be accompanied by any children (under 18 non-student), exceptions to this are:
 - When staff are visiting site (not working on campus) e.g. dropping off or picking up paperwork, and the children must remain under the supervision/ responsibility of the parent/ guardian and all times

6.12 Lone Workers and Peripatetic Workers

Principles

- a. Nottingham College believes that its employees, contractors and partners should be able to carry out their work without fear of physical attack or physical or verbal abuse.
- b. The College recognises its responsibility to provide employees who work alone with reasonable means to protect themselves from violent or abusive behaviour, and to obtain assistance in an emergency.
- c. Working from Home

Temporary home working -

During any period of temporary home working, employers need to regularly discuss these arrangements with their employees. If such work is adversely affecting the health, safety and welfare of their employees, they should take appropriate steps.

However, employers should provide workers with advice on completing their own basic assessment at home.

As any period of temporary home working extends, employers should have regular discussions with workers to assess whether additional steps are needed for example DSE assessment or review of DSE assessment.

Long-term home working -

Where employers decide to make working from home arrangements permanent, they should explain how to carry out full workstation/home safety assessments and provide workers with appropriate equipment and advice on control measures.

Objectives

- a. To implement reasonable measures to protect employees, contractors and partners who work alone from harm through violence or abusive behaviour.
- b. To implement reasonable measures to enable peripatetic employees to summon assistance.

Policy

6.12.4 Nottingham College has defined lone work as:

Work which is specifically intended to be carried out unaccompanied or without immediate access to another person for assistance or work carried out in isolation at community venues or private houses. This can be during normal working hours at a remote or isolated location within the normal workplace or off site, or, when working outside normal working hours.

- 6.12.5 Lone workers are defined as individuals who work on their own without close or direct supervision and peripatetic workers as community outreach workers working with individuals and groups of people in community venues.
- **6.12.6** Nottingham College recognises its responsibility to provide employees who work alone with reasonable means to protect themselves from violent or abusive behaviour, and to obtain assistance in an emergency.
- **6.12.7** Where an employee regularly carries out tasks involving lone working in public areas and feels at risk, they must bring it to their Line Manager's attention. Managers are also responsible for identifying individuals and groups of employees who may regularly work on their own, as defined above, and also to identify occasions where staff could be at risk from lone working.
- **6.12.8** Where any such lone working is identified, the College shall ensure that an assessment of risk is carried out and shall implement protective measures proportionate to the level of risk involved.
- **6.12.9** Any communications, tracking, alarm or protective equipment issued in pursuance of this policy shall be suitable for its purpose and, if appropriate, shall be periodically tested to ensure its correct operation.
- **6.12.10** Employees who are handling College property are expected to hand it over if a specific demand with violence is made rather than place themselves at unnecessary risk. A police report shall always be made in such situations.

6.13 **Induction and Health and Safety Training**

Principles

- a. Nottingham College recognises its statutory duty to provide health and safety training and information to employees, both at the time that they are first employed and periodically afterwards.
- b. The College also recognises the requirement to ensure that students receive relevant instruction and information in aspects of health and safety whilst undertaking a course of study at the College, and/or employed under a work placement or apprenticeship scheme at the college.
- c. The College also recognises the need to provide training and information relating to safe systems of work, plant, equipment and technology where the lack of such training is likely to lead to harm or loss.

Objectives

a. To comply with the College's statutory duties relating to the provision of training and information.

b. To increase productivity, enhance the learner journey and prevent or reduce any significant risk of harm or loss by the timely provision of appropriate training and information.

Policy

- **6.13.4** The College shall arrange health and safety training during work time for employees according to their level of responsibility and the tasks that they carry out.
- **6.13.5** The arrangements for the provision of health and safety training shall be reviewed periodically and at any other time when there has been caused to suspect that it is no longer appropriate, suitable or sufficient.
- **6.13.6** In order to secure the health and safety of employees and students, the College will provide a health and safety induction and training to all new employees.
- **6.13.7** Managers advised by the Health and Safety team are responsible for delivering the health and safety induction in accordance with the induction passport to new employees during their first week at the college.
- **6.13.8** Course tutors are responsible for providing students with adequate health and safety information and training at initial induction. This must include general college procedures i.e., fire and evacuation, accident reporting along with specific training for their course. This training may be ongoing, specific to the course and with regular testing of the knowledge gained.
- **6.13.9** Where a learner undertakes work experience, work placement or apprenticeship as part of a course arranged by the College, tutors must take steps to assess and ensure that 'relevant training' in relation to health and safety is provided by the employer offering the work placement and its duration.

6.14 **Health and Safety Monitoring and Review**

Principles

- a. Successful Health and Safety Management (HSG 65) was first prepared by the HSE's Accident Prevention Advisory Unit in 1991. It looks at health and safety management and identifies that successful management depends on effective systems that include, policy, organisation and arrangements, planning and implementation, measuring performance, review of performance and that these are backed up by a system of auditing.
- b. Nottingham College recognises its statutory duty to monitor health and safety performance and periodically review its health and safety arrangements.
- c. The College will adopt the HSG 65 framework as its health and safety management system.

d. Effective monitoring and review of health and safety arrangements will contribute to improved health and safety performance throughout the College.

Objectives

- a. To comply with the College's statutory duties relating to the health and safety monitoring and review.
- b. To identify areas for improvement relating to the College's health and safety performance and arrangements.

Policy

- **6.14.4** The College shall introduce procedures to enable the effective monitoring of the health and safety performance of its management, employees and contractors, including regular workplace inspections, accident trend analysis and health and safety auditing.
- **6.14.5** Regular reports and recommendations relating to the College's health and safety performance shall be prepared for consideration by the College's Senior Leadership Team, Board and Health and Safety Committee as appropriate.
- **6.14.6** Health and safety performance shall be included in the College's annual Self-Assessment Report.
- **6.14.7** The College shall introduce procedures to enable the effective periodic review of its health and safety arrangements.

6.15 Control of Substances Hazardous to Health (CoSHH)

Principles

- a. Nottingham College recognises its statutory duty to identify and control risks arising from the storage, transport, use and disposal of hazardous substances and from hazardous by-products used for or generated by its work activities.
- b. The term 'hazardous substances' refers to any gas, vapour, fume, liquid, solid, or dust which has been assigned a maximum exposure limit (MEL) or occupational exposure standard (OES), is marked as hazardous on the label (harmful, irritant, corrosive or toxic) or displays similar effects.
- c. Hazardous substances may cause harm when inhaled, absorbed, ingested or injected. Substances may cause harm only at the point of contact or may be systemic (affects remote body parts). The harm may be short or long term or even permanent.
- d. For these reasons, it is essential that suitable and sufficient information is available with any substance used at work and that appropriate preventative or protective measures are in place.

Objectives

- a. To comply with the College's statutory duties relating to the control of hazardous substances.
- b. To prevent or reduce any risk of harm or nuisance to employees and other persons who may come into contact or otherwise be affected by the College's use or generation of hazardous substances.

Policy

- **6.15.4** COSHH regulations make sure the risks from hazardous substances are properly controlled. College operations fall into two main areas, the office / classroom environment and the workshop / laboratory environment.
- **6.15.5** Nottingham College shall ensure that any potentially harmful substance for use at work or emitted by any work process is identified and that suitable and sufficient information is available in respect of that substance.
- **6.15.6** Preventative and protective measures shall be implemented according to the form of substance, the nature and degree of potential harm and the process during which it is used or emitted. Were reasonably practicable, measures other than the use of respiratory protective equipment (RPE) or personal protective equipment (PPE) shall be selected.
- **6.15.7** The College will take all reasonable steps to ensure that audits and CoSHH risk assessments are carried out which will detail the range of hazards associated with working with hazardous substances and the control measures necessary to control any hazards to an acceptable level. Safety Data Sheets must also be current for all chemicals in use and be available for audit.

6.16 Flammable Substances

Principles

- a. Nottingham College recognises its statutory duty to identify and control risks arising from the storage, handling and generation of flammable substances used or produced within work activities.
- b. There is an enormous variety of flammable substances to be found within the workplace. These may range from the obvious, e.g., petrol, paint thinners, welding gases and heating fuels, to the not so obvious, e.g., packaging materials and wood working dusts.

Objectives

a. To comply with the College's statutory duties relating to the safe handling and storage of flammable substances.

- b. To prevent or reduce any risk of harm to employees and other persons who may come into contact or otherwise be affected by the College's use or generation of flammable substances.
- c. To reduce the likelihood of fire and it's spreading in relation to the safe storage, use, handling and generation of flammable substances.

Policy

- **6.16.4** Nottingham College accepts that some work processes require the use of flammable substances and will take all reasonable steps to reduce the risk to the health and safety of employees and students using and working with flammable substances
- **6.16.5** The college also accepts that some work processes may produce, as by products potential flammable dusts, gases and fumes and as such will take reasonable steps to reduce their production and level of risk to the health and safety of persons working within the college.
- **6.16.6** The College will carry out risk assessments of work activities and storage arrangements and undertake all reasonable steps to reduce the risks found as a result of assessments.
- **6.16.7** The College shall provide suitable arrangements for the safe storage and transport of flammable substances ensuring that they are held in appropriate storage areas until required. Managers will arrange for employees to be given training, equipment, instruction and information necessary to ensure they take appropriate precautions and use the appropriate P.P.E in these conditions.

6.17 Radiation – Ionising and Non-Ionising

Principles

- a. Nottingham College recognises its statutory duty to eliminate or reduce as low as possible the extent of staff and student exposure to ionising radiation sources which may be found in the form of electromagnetic rays (x-rays, gamma rays) or particles (alpha and beta particles) where they are used within work processes.
- b. The College also recognises its statutory duty to protect the eyes and skin of staff and students from exposure to hazardous sources of non-ionising radiation in the form of artificial optical radiation (AOR) and electromagnetic fields (EMF) where they are used within work processes.
- c. AOR includes light emitted from all artificial sources in all its forms such as ultraviolet, infrared and laser beams. EMF includes power frequencies, microwaves and radio frequencies.

d. The college recognises it statutory duties regarding the keeping and use of radioactive substances on college premises, the requirements to obtain permits regarding use of radiation sources where required, and to protect the environment from radioactive pollution by controlling the disposal of any radioactive waste.

Objectives

- a. To comply with the College's statutory duties relating to exposure to sources of both ionising and non-ionising radiation.
- b. To comply with the College's statutory duty in relation to the keeping and use of radioactive substances on its premises.

Policy

- **6.17.4** Nottingham College shall appoint a *Radiation Protection Supervisor* (RPS) ensure that any source of ionising or non-ionising radiation for use within work processes is identified and that suitable and sufficient information is available in respect of that substance.
- **6.17.5** Risk assessments for all uses of ionising radiation will be conducted, the RPS will assist in the production of Local Rules appropriate to the radiation risk and the nature of the work carried out, and in securing compliance with them.
- **6.17.6** The college will ensure the local rules are made known and observed.
- **6.17.7** If necessary, the RPS will contact the Radiation Protection Adviser or the Environment Agency for advice regarding whether permits are required for any ionising radiation sources in use and held by the College.
- **6.17.8** Risk assessments will identify where staff or students are exposed to sources of non-ionising radiation and preventative and protective measures shall be implemented according to the form of source, the nature and degree of potential harm and the process during which it is used or emitted.

6.18 Electrical Equipment – Electrical Safety and Portable Appliance Testing

Principles

- a. Nottingham College recognises its statutory duties to protect employees from harm from contact with electricity, all reasonable steps will be taken to ensure the health and safety of employees and others who use, operate or maintain electrical equipment.
- b. The College recognises its statutory duties to periodically inspect and test electrical installations and equipment, and to maintain such installations and equipment in order to reduce the risk of harm, loss, fire or explosion.

c. Whilst there are no statutory regulations specific to portable appliance testing, the college recognises the requirement to periodically inspect and test portable electrical equipment in line with IEE guidelines.

Objectives

- a. To comply with the College's statutory duties relating to electrical installations.
- b. To introduce proactive measures to identify faulty electrical installations and equipment so as to prevent or reduce any risk of harm or loss to employees, students and other persons.

Policy

- **6.18.4** The College shall ensure that any installation, inspection, testing, commissioning, decommissioning, alteration or repair of any part of any electrical installation or appliance is performed only by persons who have been trained and authorised to perform the particular task.
- **6.18.5** Any installation, inspection, testing, commissioning, decommissioning, alteration or repair on any electrical installation shall be performed in accordance with the Electricity at Work Regulations, IEE Wiring Regulations and to the standards required by the National Inspection Council for Electrical Installation Contracting.
- **6.18.6** The College shall ensure that equipment deemed as Portable Appliances will be tested in line with the Code of Practice for In-Service Inspection and Testing of Electrical Equipment from the Institution of Electrical Engineers (IEE).

6.19 Working with Visual Display Units/Display Screen Equipment

Principles

- a. Nottingham College recognises its statutory duty to ensure that computers, computer peripherals and computer workstations provided to or used by employees in pursuance of their work comply with the standards published in the relevant schedules to the Regulations.
- b. Nottingham College recognises its statutory duty to provide free eye testing when requested by a user of computers at work.
- c. Temporary home working. There is no increased risk from DSE work for those working at home temporarily. So in that situation employers do not need to ask them to carry out home workstation assessments. During any period of temporary home working, employers need to regularly discuss these arrangements with their

employees. If such work is adversely affecting the health, safety and welfare of their employees, they should take appropriate steps

d. Long-term home working. Where employers decide to make working from home arrangements permanent, they should explain how to carry out full workstation assessments and provide workers with appropriate equipment and advice on control measures.

Objectives

- a. To comply with the College's statutory duties relating to the provision and use of computers.
- b. To prevent or reduce any risk of injury to employees who use computers at work.

Policy

- **6.19.4** The College shall ensure so far as is reasonably practicable that any computer, computer peripheral or computer workstation provided for the use of its employees or used by its employees for the performance of their work meets the standards published in the relevant schedules to the Regulations.
- **6.19.5** The College shall implement a procedure that shall allow employees to review the computer equipment and the working environment available to them and to make reasonable adjustments to their computer equipment and working environment or to request adjustments to be made on their behalf to the extent required to meet the objective stated above.
- **6.19.6** The College shall ensure that risks associated with the use of display screen equipment are prevented or controlled. The College shall also ensure that free eyesight tests and subsequently prescribed corrective appliances are, upon request, provided free of charge to employees who work or will work with display screen equipment.
- **6.19.7** Training, information and instruction shall be provided as necessary to employees who work with display screen equipment for both operational and health and safety purposes.

6.20 Workplace Equipment

Principles

- a. Nottingham College recognises its statutory duty to ensure that plant and equipment provided to employees for work purposes are safe to use, are maintained in a safe condition and are used only by suitably trained and authorised persons.
- b. There are many decisions to take when purchasing or hiring plant and equipment including cost, expected resale value, suitability for use, achievement of relevant

build and quality standards, work rate, life expectancy, portability and ease of use. Health and safety are not therefore expected to be the overriding consideration.

Objectives

- a. To comply with the College's statutory duties relating to the provision and use of plant and equipment.
- b. To prevent or reduce any risk of injury to employees who use plant and equipment at work.
- c. To ensure that health and safety matters are accorded appropriate priority when plant and equipment is hired or purchased for use at work.

Policy

- **6.20.4** All reasonable steps will be taken to ensure the health and safety of employees and others who use, operate or maintain workplace equipment. Nottingham College acknowledges that using this equipment can be hazardous and is therefore its intention to reduce the risks as far as is possible.
- **6.20.5** The College shall ensure that health and safety issues are considered when purchasing or hiring any plant, equipment or vehicle for use at work. Any plant, equipment or vehicle which is purchased or hired by the College shall be suitable for the task and used only for the task(s) for which it was specified.
- **6.20.6** Plant or equipment owned or hired by the College for use at work shall be maintained in good working order. Plant or equipment that is likely to deteriorate to a condition of danger will be maintained according to a planned preventative maintenance schedule and records of all servicing and maintenance must be held.
- **6.20.7** Employees making use of plant, equipment or vehicles provided by the College for use at work shall be given suitable and sufficient training, instruction and information in accordance with the type and level of risk associated with such use.
- **6.20.8** All machinery and equipment in any of the workshops in the College has been identified as potentially hazardous. It is important that staff follow instructions and guidelines to ensure the safety of staff and students using the machinery and working in the workshops.

Students will be given full instruction and training on how to use and maintain a range of hand tools within their area of training. Training and supervision will be given to students in the use of handheld power tools and fixed machinery. Authorisation will not be given for students to use power tools or machinery until competence can be proven.

6.21 <u>Driving at Work and College Vehicles</u>

Principles

- a. Nottingham College recognises its statutory duties to provide vehicles for use at work that are, so far as is reasonably practicable, safe and free from defect.
- b. Nottingham College understands the need to take reasonable steps to ensure that employees' personal vehicles that are used for work purposes are suitably maintained and insured.
- c. Nottingham College understands the need to take reasonable steps to ensure that employees who drive the College's vehicles or drive their own vehicles on the College's behalf are suitably trained to drive such vehicles and that such employees drive considerately and safely while at work.

Objectives

- a. To comply with the College's statutory duties relating to the provision and use of vehicles for work
- b. To prevent or reduce any risk of harm or loss to employees, students and other road users as a result of the College's work practices.
- c. To contribute to the College's reputation by encouraging considerate driving by employees while at work.

Policy

- **6.21.4** The College shall ensure that all vehicles provided by the College for use at work are suitable for the task(s) for which they have been provided and shall take reasonable steps to ensure that vehicles provided to employees for use at work are fully and effectively maintained in good working order and free from defect.
- **6.21.5** The College shall implement procedures to ensure that employees who use vehicles provided by the College carry out a regular, full and effective functionality check of the of the essential safety components of those vehicles.
- **6.21.6** The College understands the need to take reasonable steps to ensure that employees who drive the College's vehicles or drive their own vehicles on the College's behalf are suitably trained to drive such vehicles and that such employees drive considerately and safely while at work.
- **6.21.7** The College shall require evidence that employees who drive any vehicle on College business are in possession of a current and valid licence to drive that class and type of vehicle.
- **6.21.8** The College shall require evidence that employees who use their own vehicles for College business (and claim business mileage expenses) are insured to use their vehicles on college business and are in possession of a valid MOT test certificate for vehicles that are three years old and over.

- **6.21.9** The College shall provide persons who drive at work with extensive, comprehensible information regarding legal requirements, safe working practices and emergency actions relating to using vehicles on public roads.
- **6.21.10** The College prohibits the use of mobile phones while driving at work and may invoke disciplinary action against persons who use or cause or permit the use of mobile phones while driving.

6.22 Working at Height

Principles

- a. Nottingham College understands that falling from height is the most common cause of workplace deaths and serious injuries.
- b. The College recognises its statutory duties to provide safe access and places and systems of work for its employees who work above ground level.
- c. The College also recognises the need to take reasonable measures to restrict unauthorised third-party access to works at height, and to prevent equipment and materials from falling and causing harm or loss to employees and other persons.

Objectives

- a. To comply with the College's statutory duties relating to work at height.
- b. To prevent or reduce any risk of harm or loss to employees and other persons as a result of works at height.

Policy

- **6.22.4** The College shall ensure that suitable work equipment and places and systems of work are available to its employees to prevent or arrest falls from height or falling objects, and that employees are trained as necessary to make full and proper use of such equipment and systems of work.
- 6.22.5 The College shall provide suitable and sufficient training to relevant employees so as to allow them to recognise locations where the equipment provided by the College would be unsuitable equipment for working at height and shall instruct employees to refer such situations to their relevant Manager and to await instructions before carrying out the work.
- **6.22.6** The College shall implement procedures to identify tasks for which ladders, or stepladders would be unsuitable equipment for working at height and shall restrict the use of ladders and stepladders for the performance of such tasks.

- **6.22.7** Access equipment owned by the College shall be periodically examined and maintained in a safe working condition and only ladders and scaffold that are displaying a current safety code should be used.
- **6.22.8** The College shall take reasonable steps to ensure that Contractors working on the College's behalf use such safe equipment and systems of work so as to prevent or reduce the risk of harm or loss to third parties.

6.23 Confined Spaces

Principles

- a. Nottingham College recognises its statutory duties to provide safe access and places and systems of work for its employees who work in a confined space
- b. The College understands the need to take reasonable steps to ensure that employees who undertake work within confined spaces are suitably trained to do so and that such employees are made aware of the risks of such work.

Objectives

- a. To comply with the College's statutory duties relating to work in confined spaces
- b. To prevent or reduce any risk of harm or loss to employees and other persons as a result of working in confined spaces.

Policy

- **6.23.4** Confined spaces are areas which have difficult access or egress due to restricted or limited dimensions. Additional hazards may include a lack of breathable air, extremes of temperature, excessive humidity or condensation, lack of natural light, toxic gases, fumes, vapour, dust or sludge.
- **6.23.5** Nottingham College is committed to controlling access to these areas and ensuring all persons entering these areas have had the required training
- **6.23.6** The College shall undertake a risk assessment and implement reasonable measures to prevent or control work carried out within confined spaces, and for the rescue of persons in the event of an emergency.
- **6.23.7** The College shall also provide relevant employees with information regarding the significant risks identified within the working environment and the emergency arrangements.

6.24 **Personal Protective Equipment (PPE)**

Principles

- a. Nottingham College recognises its statutory duties to provide suitable Personal Protective Equipment to its employees and students to protect them against identified risks that cannot be prevented or sufficiently controlled by other more effective means.
- b. The College also accepts that Personal Protective Equipment neither eliminates risk nor prevents harm and does not contribute to the protection of other persons who may be affected by the works.

Objectives

- a. To comply with the College's statutory duties relating to the provision, use, storage and maintenance of Personal Protective Equipment.
- b. To accord priority to measures other than the use of Personal Protective Equipment for the prevention or control of risk.

Policy

- 6.24.4 Nottingham College shall implement preventative or control measures that eliminate risk, prevent or reduce harm, prevent or reduce loss or protect the greater number of persons rather than issue Personal Protective Equipment.
- 6.24.5 Any Personal Protective Equipment that has been provided by the College shall sufficiently reduce the risk of harm to the wearer and shall be suitable for the individual's use and comfort and shall not unreasonably inhibit the user's ability to carry out his or her work.
- 6.24.6 Nottingham College shall provide employees and students with sufficient and appropriate training and information to allow them to make full and proper use of Personal Protective Equipment, to inspect such equipment for damage, and to report any damaged or lost Personal Protective Equipment.
- 6.24.7 The College shall implement reasonable measures to maintain or replace as necessary any Personal Protective Equipment so that it remains effective at all times.
- 6.24.8 Suitable storage shall be provided where necessary to protect Personal Protective Equipment from damage or to prevent cross-contamination with other clothing.
- 6.24.9 No charge of any kind shall be made to any employee for the provision of any item of Personal Protective Equipment, except that if an employee is permitted to specify an item of Personal Protective Equipment that is more expensive than the item that is standard issue, and the item that is standard issue would have been suitable to prevent harm and would have been suitable for use by that employee, the employee shall be asked to contribute the cost difference between the specified item and the item that is standard issue.
- 6.24.10 Students may in some instances be required to provide their own safety boots and protective overalls.

6.25 'Out of College' Trips and Visits

Principles

- a. Nottingham College recognises its statutory duty to ensure the health and safety of anyone else on the premises or anyone who may be affected by its activities. This includes participants such as students participating in 'out of College' activities such as a trip or visit.
- b. The College also recognises its statutory duty to assess the risks of trips and visits, implement control measures as necessary to reduce levels of risk to an accepted level and communicate the requirement of these measures.
- c. Tutors, other staff or volunteers in charge of students whilst on an 'out of College Activity' also have a common law duty to act as any reasonably prudent parent would do in the same circumstances.

Objectives

- a. To comply with the College's statutory duties relating to planned out of college activities such as trips or visits involving students.
- b. To prevent or reduce any risk of harm or loss to employees, students and other persons as a result of the participation on pre-arranged out of college trips and visits.

Policy

6.25.4 Educational trips and visits can form part of a student's training programme making it necessary for staff to accompany students to a wide range of venues and activities. A procedure and application pack within that procedure, support this policy to ensure the relevant assessments and control measures are in place.

6.26 Work Placements, apprenticeships and work-based learning

Principles

- a. Whilst on work experience, students are designated as employees for the purposes of health and safety legislation, and they must be afforded the same health and safety protection as other employees.
- b. The college recognises its duty-of-care to ensure that students undertake work experience in a healthy and safe environment.

Objectives

Nottingham College Health & Safety Policy





- a. To comply with the College's statutory duties relating to students undertaking work experience as part of their course.
- b. To prevent or reduce any risk of harm or loss to students and other persons as a result of the participation on pre-arranged work experience.

Policy

- **6.26.4** Young persons are considered to be at greater risk from workplace hazards due to their lack of experience and maturity, and are therefore owed a greater duty of care, even when on work experience, they are designated as employees for the purposes of health and safety legislation, and they must be afforded the same health and safety protection as other employees.
- **6.26.5** Where a learner undertakes work experience or an apprenticeship as part of a course or an apprenticeship arranged by the College, placement staff must take steps to assess and ensure that 'relevant training' in relation to health and safety is provided by the employer offering the work placement and its duration. A procedure supports this policy to check and monitor health, safety and welfare issues of Work Placement Providers.
- **6.26.6** The College also provides opportunities for work placement students within the College. In these cases the College will meet its obligations with regard to the Health and Safety of the work placement students in accordance with legislation relating to young people at work.

6.27 Catering and Vending

Principles

a. Nottingham College recognises its statutory duties in relation to food hygiene within its areas of catering and vending.

Objectives

- a. To ensure the College does not include anything in food, remove anything from food or treat food in any way which means it would be damaging to the health of people eating it.
- b. To ensure that the food served or sold is of the nature, substance or quality which consumers would expect.
- c. To ensure that the food is labelled, advertised and presented in a way that is not false or misleading.

Policy

Nottingham College Health & Safety Policy





6.27.4 Nottingham College acknowledges the hazards associated with food hygiene (such as contamination by harmful bacteria) and will exercise all reasonable precautions and due diligence to maintain the highest standards of catering and vending.

6.28 Safety Signs and Signals

Principles

a. Nottingham College recognises its statutory duty to display specific safety signs whenever there is a risk that has not been avoided or controlled by other means, e.g., by engineering controls and safe systems of work to notify employees and others who may be affected of either danger present or, of safe conditions.

Objectives

a. To comply with the College's statutory duties relating to displaying appropriate safety signage.

Policy

6.28.4 Nottingham College will take all reasonable steps to ensure that all safety signs, signals and makings (pipe work etc.) used or displayed on College premises to warn and instruct staff and students of risks to their health and safety, including fire safety, will comply with current legislation as regards colour, size, shape and pictogram.

6.29 Pressure Systems

Principles

a. Nottingham College recognises its statutory duties relating to systems or equipment which contain a gas or a liquid under pressure.

Objectives

a. To comply with the College's statutory duties relating to providing a safe workplace and safe work equipment.

Policy

6.29.4 Nottingham College will, so far as is reasonably practicable, ensure that all pressure systems used are safe. The design, construction, repair and modification of

pressure systems will be managed to prevent danger and such relevant information as is required in law will be made available and kept for record purposes.

6.30 **Waste Control and Disposal**

Principles

a. The college recognises its duty towards the environment regarding waste and its disposal, which will be responsibly conducted with only approved carriers used for special waste as legally required.

Objectives

- a. To comply with the College's statutory duties relating to waste control and disposal.
- b. To ensure employees, students, other persons or the environment are not exposed to harm from any hazardous waste produced during any college activity.

Policy

- **6.30.4** Nottingham College have assessed waste control and disposal and have made provision for waste product and material to be collected and stored in suitable identified containers. Arrangements are in place to dispose of waste product and material in an environmentally friendly way.
- **6.30.5** All employees are responsible for keeping places of work neat and tidy, disposing of waste materials in containers designed to eliminate spillage, fumes and dust or for recycling.
- **6.30.6** The College will maintain a Waste Data Stream and information for the disposal of special waste via the Services Manager, in cooperation with staff from areas where special waste is produced, along with local enforcement officers and only specialist contractors.

6.31 Slips, Trips and Falls

Principles

a. HSE statistics suggest that slips and trips are a major cause of accidents to education employees, pupils/students and others and are significantly high in the food industry.

Nottingham College Health & Safety Policy





Objectives

a. To assess areas of risk and implement reasonable and practicable control measures to control slip and trips risks within the College environment.

Policy

6.31.4 Statistics show that slip, trip and fall injuries result in many absences from work, cause unnecessary pain and suffering to employees and economic loss to an organisation. The College slips trips and falls procedures are intended to reduce the risk of slip, trip and fall injuries as low as reasonably practicable.

6.32 Visitors

Principles

a. Nottingham College recognises its statutory duties to protect people not in its employ such as visitors from harm, loss and unreasonable inconvenience because of the College's work activities.

Objectives

a. To comply with the College's statutory duties relating to the protection of persons not employed by the organisation.

Policy

- **6.32.4** Nottingham College recognises its responsibility for all visitors to the College and provision has been made to address this responsibility.
- **6.32.5** The College shall implement all appropriate and reasonably practicable measures to protect members of the public from any unacceptable risk of harm or loss due to its operations and shall provide suitable information to members of the public where appropriate to allow them to avoid such risk.
- **6.32.6** The College shall arrange such periodic inspections and tests of equipment and facilities that are provided for the use of by students and other persons as are required by law or are otherwise necessary to protect such persons from any unacceptable risk of harm or loss.
- **6.32.7** The College's employees shall always treat members of the public courteously and respectfully.
- **6.32.8** Reasonable care shall be taken to ensure that any of the protective arrangements made under this policy are suitable and sufficient for the needs of disabled and other vulnerable persons who are likely to benefit from the arrangements.

6.33 Smoking

Principles

- a. Research from a variety of sources indicates that there is an increased risk of lung cancer, heart disease and chronic respiratory illnesses in non-smokers who regularly breathe in another person's smoke.
- b. Nottingham College recognises that smoking at work is covered as a public health issue by the Department of Health, with a few exceptions all public and places of work became smoke free in Great Britain by 1st July 2007.

Objectives

a. To comply with the College's statutory duties relating to enforcing a smoke free workplace and to commit to providing a safe and healthy place to work, in which all employees are free from increased risks of poor health through passive smoking.

Policy

- **6.33.4** Nottingham College operates a no smoking policy throughout all its buildings, sites and vehicles; smoking is only permitted in designated areas and this policy applies to all staff, students, visitors and contractors.
- **6.33.5** The College recognises its responsibility to provide those who use its premises with a smoke free environment and aims to have a strict adherence of its no smoking policy, as the college recognises that this can also help reduce the risk of fire, especially in higher risk areas.
- **6.33.6** The College shall require staff, students and visitors to comply with any local requirements and where designated shelters are in operation, to use these and to maintain good housekeeping practices.
- **6.33.7** Nottingham College recognises its duties regarding fire and evacuation procedures and persons will be expected to avoid smoking when evacuating and assembling outside whilst the alarms are sounding.
- **6.33.8** Employees who wish to stop smoking will be provided with appropriate support in which to help them stop.
- 6.33.9 E-cigarettes fall outside the scope of smoke-free legislation as the act of smoking requires tobacco to be burnt and e-cigs contain no tobacco and do not burn their fuel. E-cigarettes must not be used inside College buildings or College vehicles. E-cigarette users have the right to a smoke-free environment and therefore the use of e-cigarettes cannot be confined to designated smoking areas. E-cigarettes can only be used in the open air outside of College buildings and vehicles, but users should be mindful of their environment and act in a courteous manner.

6.34 Violent Conduct/Bullying

Principles

a. Nottingham College believes that its employees, students, contractors and stakeholders should be able to carry out their work without fear of violent conduct.

Objectives

a. To implement reasonable measures to protect employees, students and partners within the College environment from harm through violence or abusive behaviour.

Policy

- **6.34.4** Violent conduct is defined as any incident in which an employee or student is abused, threatened or assaulted either physically or verbally by a member of staff, a student or member of the public in circumstances arising out of the course of his or her employment or education at the college.
- **6.34.5** The College has implemented measures/procedures in to protect staff and students from the psychological and physical effects of violent conduct and/or bullying.

Legal Requirements

- Health and Safety at Work etc. Act 1974
- Management of Health and Safety at Work Regulations 1999

6.35 Work Related Stress.

Principles

a. Nottingham College recognises that Work Related Stress (WRS) can be a cause of ill health and can lead to a loss of productivity and absence from work.

Objectives

a. To reduce the occurrence of stress and its associated ill health effects.

Policy

- **6.35.4** Nottingham College recognises that work-related stress is a health and safety issue and that risks to health can be minimised by the implementation of good management practices.
- **6.35.5** Nottingham College is aware that, whilst a degree of controlled stress can be a positive force at work, excessive pressures can have a negative effect on health, performance and safety.

Nottingham College Health & Safety Policy





- **6.35.6** Nottingham College has a duty to inform everyone within the college of its commitments to minimising the harmful effects of stress, the procedures that should be followed and who is responsible for each step.
- **6.35.7** The college is committed to promoting good health at work and is therefore active in recognising any negative effects that stress may have on individuals at work, and for providing suitable support mechanisms for members of staff suffering from the negative effects of stress.
- **6.35.8** The college also recognises where negative stress could be a factor for large groups of staff, especially during major change and mergers, and is committed to reduce such stress as-far-as reasonably practicable, where it can by good management and communication.
- **6.35.9** Through the risk assessment process, Nottingham College will continue to identify stress related hazards and assess mental and physical risks to health and safety with the objective of reducing them, as-far-as-practical.
- 6.35.10 Where staff are identified as having excess stress, Nottingham College will provide the necessary mechanisms to promote a return to full health as quickly as possible. Members of staff are encouraged to refer to their Line Manager, a Head of Faculty or the People Services Department in full confidence. Members of staff will be offered any relevant counselling, help with stress reduction techniques and an appraisal of their work situation.
- **6.35.11** Nottingham College has an open approach to stress and the potential ill health caused and therefore is active in its prevention and is open and fair in its, management of stress, individuals and its processes for reporting.

6.36 <u>Manual Handling</u>

Principles

- a. Manual handling accounts for around a third of injuries reported to the enforcement authorities, approximately half of which are injuries to the back. Such injuries can often result in lost time at work and considerable pain and suffering to the injured party.
- b. Nottingham College recognises its statutory duty to prevent or control the risk of harm to employees arising from the manual handling of loads at work.

Objectives

Nottingham College Health & Safety Policy Issue Date: Oct 23





- a. To comply with the College's statutory duties relating to the prevention and control of manual handling risks.
- b. To prevent or reduce any harm, suffering and lost time caused by manual handling injuries.

Policy

- **6.36.4** Manual handling refers to any task which requires the use of bodily force and includes lifting, supporting, pulling, pushing or transporting a load. Statistics show that manual handling is one of the most common causes of injury in the workplace and may have long-term effects.
- **6.36.5** Nottingham College recognises the need to reduce risks from manual handling operations to the lowest reasonably practicable level for both business purposes and the reduction of injury and ill health.
- **6.36.6** The College shall therefore arrange its work activities to avoid the need for manual handling where reasonably practicable, or reduce the risk whenever manual handling cannot be avoided.
- **6.36.7** Where practicable, lifting and carrying equipment such as hoists and trolleys will be provided. Where this is not practicable reasonable steps will be taken to minimise the risk of injury to staff and students through manual handling activities.
- **6.36.8** Suitable training shall also be provided to all employees who are likely to undertake manual handling operations which involve a risk of injury, Managers will ensure suitable manual handling risk assessments are carried out and the recommended control measures are implemented.

6.37 Noise and Vibration.

Principles

a. Nottingham College recognises its statutory duties to prevent or reduce the risk of harm to its employees as a result of exposure to excessive noise or vibration at work.

Objectives

- a. To comply with the College's statutory duties relating to the prevention and control of the risk of harm caused by exposure to excessive noise or vibration.
- b. To prevent or reduce any harm, suffering and lost time caused by exposure to excessive noise or vibration.

Policy

Nottingham College Health & Safety Policy





- **6.37.4** Nottingham College recognises its statutory duties to prevent or reduce the risk of harm to its employees and students as a result of exposure to excessive noise or vibration whilst within the college environment.
- **6.37.5** The College will take all reasonable steps necessary to ensure that the risk of hearing damage to staff and students who work with noisy equipment or in a noisy environment is reduced to a minimum.
- **6.37.6** The College shall ensure through its purchasing procedures that any plant or equipment purchased or hired for use at work does not generate unreasonable levels of noise and vibration.
- **6.37.7** Plant and equipment that may generate harmful levels of noise or vibration shall be maintained in good working order so as to reduce the likelihood of noise and vibration levels increasing significantly through wear and tear.
- **6.37.8** The College shall carry out surveys as necessary to establish which employees and students are likely to be exposed to levels of noise or vibration that are likely to cause harm and shall implement suitable measures to reduce such exposure to a reasonable level.
- **6.37.9** Where necessary the College shall introduce a programme of health surveillance in consultation with employees and a registered medical practitioner for employees who are shown through surveys to be regularly exposed to harmful levels of noise or vibration, or who have been diagnosed as having symptoms of harm caused by exposure to noise or vibration.
- **6.37.10** The College shall provide relevant employees with information regarding the significant results of any relevant surveys, the methods available to reduce risk, the nature of Noise Induced Hearing Loss (NIHL) and Hand-Arm Vibration Syndrome (HAVS), including causes, symptoms and effects, the results of any health surveillance, and the course of action to take should symptoms become apparent.

6.38 External Venues – Delivery of Curriculum

Principles

- a. The college will from time to time use facilities other than its own or leased by the college, to conduct classes or whole courses. Many of these are in the community and owned by other organisations, with a number being in community halls, council properties, and schools or mixed-use buildings.
- b. Nottingham College recognises its statutory duties to ensure that employees and students are in a safe and healthy environment with suitable welfare facilities, regardless of the buildings and teaching location being used.

Objectives

Nottingham College Health & Safety Policy Issue Date: Oct 23





a. To comply with the College's statutory duties relating to the requirement to ensure external venues are assessed and provide a safe and suitable environment for the delivery of curriculum courses.

Policy

- **6.38.4** Nottingham College recognises its statutory duties to ensure the suitability of facilities which may be utilised to deliver training on behalf of the College. It is the responsibility of staff organising any course in venues other than those under the strict control of the college, to ensure that such checks are carried out so as to evidence that they provide a safe and suitable teaching environment and prevent or reduce the risk of harm to its employees and students.
- **6.38.5** Where students are being taught by an external organisation, staff must check and ensure that the organisation has appropriate and adequate health and safety systems and documentation in place, including insurance arrangements, which is applicable to the courses and activities being conducted

Legal Requirements

6.39 **Safety Procedures**

Principles

a. Nottingham College recognises its statutory duties to undertake health and safety risk assessments for all its activities. Where hazards are identified that involve increased levels of risk, Written safety procedures will be completed to provide staff and students with information and detailed written methods of work to enable them to work safely.

Objectives

a. To comply with the College's statutory duties relating to the requirement of suitable and sufficient risk assessments being conducted and where necessary are supported by detailed written safety procedures.

Policy

6.39.4 Where risk assessment identifies activities with hazards which have increased levels of risk, risk assessments will be supported within each School or Department with appropriate "arrangements" in the form of written safety procedures for both staff, and where applicable students.

6.40 **Additional Activities**

Principles

Nottingham College Health & Safety Policy





a. The legal framework for health and safety identifies that all employers have a duty-of-care to ensure so far as is reasonably practicable, the health and safety of anyone who may be affected by their activities. In essence this includes any and all activities that are conducted in the name of the college for students, staff, visitors and the general public.

Objectives

a. To ensure that activities conducted in the name of the college which are not strictly related to either specific courses or the general working of the College will be treated the same, as for all other activities in terms of the requirements of health and safety.

Policy

- **6.40.4** The college shall ensure that all additional activities are planned, organised and undergo suitable and sufficient risk assessment with appropriate control measures implemented.
- **6.40.5** The college will also ensure that any activity that is deemed as non-insurable or is of significant high risk will not be undertaken.

Legal Requirements

Health and Safety at Work etc. Act 1974

6.41 Occupational Disease - Blood Borne and Respiratory Viruses and Zoonosis

Principles

- a. Nottingham College recognises its duty to ensure that employees are aware of common occupational diseases relevant to their work, and to implement reasonable measures to protect employees from exposure to such diseases.
- b. The College will work with national guidance, implementing measures to maintain the safety of the members of the public, staff and students. Report, consult and work with local health protection teams from Public Health England in protecting the safety at the College.
- c. The BBV's of most concern are hepatitis B and C and Human Immunodeficiency Virus (HIV). Those most at risk are employees or students who may receive a needle stick injury whilst providing beauty treatments such as epilation.
- d. Zoonosis refers to diseases carried by animals which may be transmitted to humans. Well known examples are anthrax, rabies and malaria. However, employees in the UK (especially construction and maintenance workers) are more likely to come into contact with leptospirosis (rat's urine), psittacosis (dried pigeon waste products) and tetanus (soil used for animal husbandry).

Objectives

- a. To comply with the College's statutory duties relating to the prevention, control and reporting of occupational diseases.
- b. To improve employee awareness about relevant occupational diseases.

c. To prevent or reduce any occurrence of occupational diseases amongst employees.

Policy

- **6.41.4** The college shall identify groups of employees who are, by the nature of their work, at risk of exposure to occupational diseases, and shall implement reasonable measures to prevent or reduce such risk.
- **6.41.5** At risk groups shall be provided with information regarding the risks of exposure to, consequences of and preventative and protective measures against such exposure.
- **6.41.6** The College shall encourage at-risk employees to be vaccinated against occupational diseases if such vaccination is available. The College shall arrange for such vaccinations to be available free of charge to at-risk employees.

6.42 **Subcontractors and Employers**

Principles

- a. The college presently and will from time to time allow the use of facilities to subcontractors and employers, to conduct classes or whole courses.
- b. Nottingham College recognises its statutory duties to ensure that employees and students are in a safe and healthy environment with suitable welfare facilities, regardless of who managers the part or whole of the college buildings and teaching location being used.

Objectives

- a. To co-operate to ensure emergency action plans that are effective, efficient and suitable to meet Nottingham College's statutory duty.
- b. To contribute to the improved safety of the College's employees, students and visitors through the effective evacuation of buildings and premises.
- c. Take all reasonable steps to co-ordinate the measures needed to comply with the requirements and prohibitions imposed upon them by legislation.
- d. Considering the nature of both the college and the subcontractor or employer's activities. Take all reasonable steps to inform each other of the risks to their employees' health and safety arising out of or in connection with activities conducted.

Policy

6.42.4 Nottingham College recognises its statutory duties to ensure the suitability of facilities which may be utilised to deliver training on behalf of the College. It is the responsibility of Partnership Performance Manager, faculty area or director of any limited company within the college, to ensure that such checks are carried out so as

to evidence that the subcontractors or employers provide a safe and suitable teaching environment and prevent or reduce the risk of harm to its employees and students.

6.42.5 The college must check and ensure that the organisation has appropriate and adequate health and safety systems and documentation in place, including insurance arrangements, which is applicable to the courses and activities being conducted. The College will visit the site to ensure that the health, safety and welfare are in place.
